	JC also updated on some positive news from the wider SSE Thermal business. SSE Thermal has recently announced plans with Equinor to jointly develop two first-of-a-kind, low-carbon power stations in the Humber region. Keadby 3, in North Lincolnshire would be one of the UK's first power stations with carbon capture and storage (CCS) technology. Keadby Hydrogen could be the world's first major 100% hydrogen-fuelled power station. This is exciting news for SSE but the projects have the potential to create thousands of skilled, green jobs in the area. The projects would utilise the hydrogen and CO2 pipeline infrastructure being developed by the Zero Carbon Humber partnership.
