Purpose of Meeting





To inform the group of the status of the Ferrybridge C power station, the Etex gypsum facility, the operations of the Ferrybridge Multifuel 1 plant, the construction of the Multifuel 2 power station and the development of the Ferrybridge D CCGT project.

Meeting Notes

Item

1 Introductions and Safety Moment

NH welcomed the group and gave a safety moment based around slips, trips and falls.

2 Review of previous minutes

Previous minutes agreed as final

3 Ferrybridge D Project

JL presented the project update from slides.

JM raised a question regarding the aesthetic of the plant – JL explained that this question had been asked throughout the formal consultation phase and feedback received was being taken into consideration by the project team.

RW asked if the lighting design for the new plant would be low level. JL explained that whilst final design of the lighting scheme had not yet taken place, this feedback would be taken account of. Lighting required for the new plant would need to meet standards to ensure safety.

DS asked if rules and regulations on emissions would change should Brexit occur. IF explained that the Industrial Emissions Directive stand in UK law so there would be no changes to the current standards.

4 FM1 Update

MH provided an update on the FM1 operational plant (see slide pack)

RW raised the issue of China no longer accepting plastics as fuel and asked if FM1 accepted plastics as fuel.

MH explained that FM1 does accept plastic, however, no increase has been seen in the plants fuel. FM1 uses a mixed fuel supply so could burn plastics but would still operate within its permitted emissions permit.

5 FM2 Update

AS provided an update on construction activities at the site (see slide pack)

6 Ballast Phoenix IBA Plant Update

JH provided an update (see slide pack)

KS thanked JH for the site tour which had recently taken place and provided some feedback to the group. KS explained that feedback from the group that had attended was very positive. The only dust at the site had been contained inside of the plant. No breathing protection etc had been required and there was no noticable noise outside of the building.

7 ETEX Update





CH provided an update to the group (see slide pack)

DS explained that there is a road on the site that runs parallel to the River and it had been noticed by a local resident that HGV's had been travelling on the highway. MW explained that the use of this road was usually limited to SSE security patrols. MW to investigate and report back at next meeting. JM asked where in the plant the dust filters are located. MW explained that filter bag units are contained within the building and each has an alarm fitted.

8 Ferrybridge C Update

PH gave the group an update of current activities at the site (see slide pack)

JM asked if there would be information provided to the public around timings of the main blowdown events and potential viewing points. PH explained that the project team are currently working with Highways and the Police to organise the co-ordination. More information would be shared once available.

CG asked for confirmation of the site working hours. PH confirmed that these are 8am to 6pm Monday to Friday

8am to 2pm Saturday

With potential requirement to undertake critical tasks outside of these hours.

10 AOB

DS asked if FM1 and FM2 would be required to remodel emissions in light of the removal of Ferrybridge C. NH explained that this would not be the case, however Ferrybridge D would be required to take into account any other operational contributors in its DCO application.
