1	Apologies for absence Apologies as above.
2	Minutes of the previous meeting (18 October 2018) The minutes of the previous meeting were reviewed and agreed.
3	Matters Arising A representative from Aldbrough Parish Council was invited to attend, as stipulated in the last meeting
4	Aldbrough Operations Operations at the site have been continuing as normal. There will be an annual outage from 6 th – 19 th May. This will involve 24hr work, with lighting towers and increased number of personnel of about 20-30 people. There will be cranes, deliveries and weekend working.

7 Community Concerns / Comments

Planning permission

The original planning consent for phase 2 is still in place. There has been adequate pre-construction work to meet consent, however there are no plans to start phase 2.

Monopile structure out at sea

The metal structure which can be seen from the shore has a rolling licence from the Crown Estate until 2021. It used to remove brine from the caverns. Next steps are currently being looked at.

Pipes on the beach

Planning has been agreed with the council to keep the pipes in place, rather than to cut them out in case it causes more erosion. These pipes are regularly checked – please see photographs attached. There are fixed labels to show they are not hazardous and they are big enough so as not to be a trip hazard.

St. Michael's Wood

Positive stories have come from the community regarding the woodland; it is now feeling like their own, and this is shown by the community helping to re-stake trees after strong winds and attending a walk-around with a local expert. SSE employees are given one day a year to volunteer, called Be The Difference, with scope to ask for more than one day. There are 60 – 70 people across both gas storage sites, therefore a reminder will be circulated to all regarding the option of helping at the woodland.

8 AOB + Public Discussion

A resident heard a noise, however they thought it came from another location, as it sounded like a bearing on a conveyor.

This year's apprenticeship scheme is now taking place. An apprentice will be taken on in September as an electrical, control and instrumentation technician (EC&I). There are currently two apprentices at HETA, due to finish this year.
