THE PETERHEAD LOW CARBON POWER STATION PROJECT – SUBMISSION OF ADDITIONAL INFORMATION

THE ELECTRICITY ACT 1989 – SECTION 36

THE TOWN AND COUNTRY PLANNING (SCOTLAND) ACT 1997

THE ELECTRICITY WORKS (ENVIRONMENTAL IMPACT ASSESSMENT) (SCOTLAND) REGULATIONS 2017

I write on behalf of SSE Thermal Generation (Scotland) Limited (the 'Applicant') in respect of the application for consent under Section 36 of the Electricity Act 1989 for the Peterhead Low Carbon Power Station Project (the 'Proposed Development') that was submitted to the Scottish Ministers in March 2022 (ECU Ref: ECU00003433).

The application seeks consent to construct and operate a low carbon combined cycle gas turbine generating station with a capacity of up to 910 megawatts, including carbon capture plant and ancillary development on land at and within the vicinity of Peterhead Power Station, Boddam, approximately 1.5 kilometres south of Peterhead, Aberdeenshire, AB42 3BZ (centred on National Grid Reference 412597, 842972). The Proposed Development is subject to an Environmental Impact Assessment ('EIA') and an EIA Report has been produced to accompany the application for Section 36 consent.

The Applicant has submitted further Additional Information ('Additional Information 3') in respect of the Proposed Development to the Scottish Ministers, which includes:

- an Additional Information Report dated 16 May 2025, including:
 - Appendix A – Updated Non-Technical Summary of the EIA Report;
 - Appendix B – Updated EIA Report Chapter 18 'Climate Change and Sustainability' and Appendix 18A 'Sustainability Review'; and
 - Appendix C – Updated EIA Report Chapter 21 'Summary of Likely Significant Effects'.

- an Updated Planning Statement dated 19 May 2025.

The Applicant is undertaking notification and publicity in respect of the Additional Information and a copy of the publicity notice that is being sent to consultee and published in relevant newspapers is attached.
