Project update

Funding

- Negotiation process for Government Funding ongoing. Expect decision on funding award by December 2023.

Engineering Design and Planning

- Front End Engineering Design (FEED) programme delayed – Impact on Town and Country Planning Application date. Target now end of November/early December.
- Photo montages to be developed and shared with CLG in advance of planning application submission.

Pipeline inspections

- Work ongoing to assess the condition of the brine discharge pipe. Area excavated at the clifftop for pipe access. Further inspections required – logistics currently being arranged.

A fourth phase for the world's largest offshore windfarm

- Public consultation update – reminder of 7 November closing date
- Unclaimed land notices
- Nocturnal surveys from October to March. Thermal imaging surveys will be undertaken on agricultural land, where inland wintering waders (golden plover, redshank, curlew etc.) may be roosting and where migratory geese are likely to roost and forage in arable fields overnight. This is in order to survey birds associated with the Humber Estuary Special Protection Area (SPA).
