	<p>No feedback received from the community. Jayne Collings will return from maternity leave at the end of January 2020.</p>		
7	Community Concerns / Comments		
	<p>Monopile structure out at sea</p> <p>The feasibility for either keeping or removing it is being considered, the deadline to decide on a course of action is 2021.</p> <p>Pipes on the beach</p> <p>Undergoing continued engagement with the council. Aldbrough are liaising with a civil contractor to look at the work to remove the pipes, considering the implications of bringing large equipment onto the beach.</p> <p>In August, there was an inflow of sand which covered the pipes up again.</p> <p>The pipes are large and very visible and therefore do not present a “trip hazard” - photos were sent round the CLG. It is a watching brief at the moment, to be reviewed again in the spring.</p> <p>The surrounding environment</p> <p>The charity walk took place 7 September, whereby it was noticed some trees need to be thinned for the health of the woodland.</p> <p>The pond has become overgrown with weeds (not algae) and thistles. MGi will get advice for how best to approach this and share solutions with the CLG.</p> <p>The gate is not catching – MGi to investigate</p> <p>Loose dogs in the fields – Parish Council to lead on finding a solution such as putting up notices, Aldbrough to support.</p> <p>It is with Aldbrough’s permission that the community can go into the planted area and help tidy up removing any empty tubes and stakes, etc.</p> <p>Apprentices</p> <p>Two apprentices have finished their first year at HETA and are now at Aldbrough gas storage, plus a new apprentice started at HETA this year, to start at Aldbrough in September 2021.</p> <p>Charity days</p> <p>Aldbrough’s next charity day is with Viking FM’s Mission Christmas – to wrap and distribute presents or shop for underrepresented age groups. Staff at Aldbrough can use their Be The Difference Day to take part.</p>
