4. ALDBROUGH HYDROGEN PATHFINDER Project update

Town and Country Planning Application

- Application is still progressing through validation.
- Commitment remains to share links to the application once validation is complete.

Screening

- Remainder of site screening (not completed in last planting season) to recommence in December placeholder secured for first two weeks in December.
 - Screening to be completed highlighted in next slide
- Additional screening request in progress lease for land area requested to be screened in review with lease holder. Lease to be amended to allow SSE-Equinor to take back land when required. Draft plans received from TI – next steps to be agreed following land lease confirmation.

Area 2 - North-east corner of existing site



Original plans – October 2023

- Light blue hatched area to be bunded and screened [c. 52 relocated trees].
- Dark blue hatched area with existing hedge to be enhanced [c. 40m] with additional tree screening [c. 30 relocated trees].
- Lime green hatched area to be screened using existing trees [c. 64 related trees].
- Underplanting where required in all areas [c. 73 trees].

Updated plans - November 2023

- No change to light blue and dark blue areas.
- Right side of lime green area unable to be screened due to landowner planting restrictions [reduction of c. 36 relocated trees].

- Light blue hatched area Bund developed and to be screened in December 2024. Dark blue hatched area Screening completed in April 2024.
- Lime green hatched area
 - Left: One row of trees planted on left side of area (portion of SSE land).

 Additional row of trees to be planted where space allows (not to cross over into neighbouring landowner's boundary)
 - Right: Landowner has not granted permission to screen this area. Engagement is ongoing to discuss is any alternative option can be progressed.

Area 6 - Bridleway - Additional Screening (February CLG)



Additional screening request from February 2024 CLG meeting

- Request to screen blue box area along bridleway.
- Transferring pre-planted trees for screening would be preference over new trees.

- SSE Land team have held discussions with farmer who leases landed to assess feasibility of screening.
- Process of removing land area to be screened from farmer's lease in progress.
- Screening plan option received from TI.
- Next steps to be aligned following completion of land lease agreement amendment.

15. ALDBROUGH HYDROGEN STORAGE


- Archaeological site investigation commenced on site and should be complete early November.
- Ecological surveys to validate previous work to ensure no significant changes, completed.
- Seismic Survey:
 - We are continuing to engage with landowners and agents across the proposed survey area to discuss land access.
 - Demo Day planned for early November date TBC. Subject to when a Vibroseis vehicle can be brought to Aldbrough.

We have provided the CLG with a more detailed explanation for the required size of the survey area.










12. AHS – PROPOSED LOCATION FOR 9 CAVERNS

Notes:

- Six key areas where screening was planned for.
- Following slides outlines the plans and progress updates for each area in detail.
- Areas of land that were not owned by SSE or Equinor required additional landowner discussions which has resulted in some modifications to the proposed plans.

Area 1 – South-east corner of existing site



Original plans – October 2023

- Orange hatched area to be screened with trees from light orange dashed area (south of existing site)[c. 175 relocated trees].
- Underplanting where required [c. 206 trees].

Updated plans – February 2024

Additional rows of trees on top of bund included in plans [orange rectangle
 c. 100 additional relocated trees].

Status – As of October 2024

Screening completed in April 2024.



Area 2 - North-east corner of existing site



Original plans – October 2023

- Light blue hatched area to be bunded and screened [c. 52 relocated trees].
- Dark blue hatched area with existing hedge to be enhanced [c. 40m] with additional tree screening [c. 30 relocated trees].
- Lime green hatched area to be screened using existing trees [c. 64 related trees].
- Underplanting where required in all areas [c. 73 trees].

Updated plans - November 2023

- No change to light blue and dark blue areas.
- Right side of lime green area unable to be screened due to landowner planting restrictions [reduction of c. 36 relocated trees].

Area 3 - Perimeter of Phase 2 land



Original plans – October 2023

- Pink line along the perimeter of the Phase 2 land proposed to be screened (below bund) – subject to assessment [c. 800 relocated trees].
- Pink hatched area in second field of Phase 2 may be screened [c. 275 relocated trees].
- Underplanting where required in all areas [c. 630 trees].

Updated plans – February 2024

- Pink line Multiple revisions:
 - Western side of pink line (left of yellow box) to be screened with single row of Evergreens [c. 300 new trees]
 - Eastern side of pink line (right of yellow box) no longer to be screened due to limited value screening would have – narrow area, limited space to plant new, below bund so minimal height impact.
 - Additional row of Evergreens to be planted on top of bund along blue box area to provide greater coverage on higher ground (thinnest area of willows) [c. 290 new trees].
- Pink hatched area unchanged.

- Revised Pink line completed in April 2024.
- Pink hatched area completed in April 2024.

Area 4 - North area of Phase 2 Field 2



Original plans – October 2023 - No change

- Turquoise hatched area to be screened with trees from light turquoise dashed area (existing Phase 2 screening) [c. 210 relocated trees].
- Underplanting to be completed as required [c. 1200 trees].

- Tree relocation completed in April 2024.
- Underplanting completed in April 2024.



Area 5 - Meadley Land



Original plans – October 2023

 Red lines indicate areas where hedging could be re-instated following landowner discussions [c. 400m of hedging].

Updated plans –February 2024

- Left line
 - Can enhance hedgerows in area where white arrow extends – no new planting on remainder of line [c. 135m of new hedging].
- Right line
 - Native trees can be planted where arrow extends – no new planting on remainder of line [c. 36 native broadleaf trees].

Status - As of October 2024

Screening completed in April 2024.

Area 6 - Bridleway



Original plans – October 2023

 Yellow lines indicate areas where hedging could be re-instated [c. 710m of hedging].


Updated plans –February 2024

- Left line
 - Hedgerow gaps can be filled but access gap (red box) to be left at southerly end.
- Right line
 - New hedging at northerly end (blue arrow)
 - Hedgerow gaps can be filled but access gap (red box) to be left at southerly end (green arrow).
- Increase to c. 870m of new hedging and enhancements across both lines.

Status - As of October 2024

 Screening completed in April 2024.
